- b) <u>EV Media Advertising Sign Site Leases</u> Executive Director Randy Tucker reviewed with Commissioners and staff the two advertising sign site leases which the Port took over from the Lois Higgins Trust when the Port purchased the Puterbaugh property in December 2016.

Commissioner Lyall moved and Commissioner Shenyer seconded a motion to consult the Port Attorney for advice regarding renegotiating the Port's advertising sign site lease with EV Media LLC. Motion carried.

c) <u>2022 American Rescue Plan Act (ARPA) Funds Update</u>
Executive Director Randy Tucker shared his progress with the Port's application for ARPA funds.

## d) Executive Director's Report

i. <u>Broadband Update</u> - CERB Planning Grant Petrichor Executive Director Joe Poiré and Port of Whitman Broadband Director Kalvin Johanson presented information to Commissioners and staff about the CERB planning grant for broadband the Port has received and what services Petrichor can provide to the Port in a Broadband Feasibility Study.

Commissioner Shenyer moved and Commissioner Lyall seconded a motion to authorize Executive Director Randy Tucker to sign an Interlocal Agreement for Consulting Services with Petrichor Broadband with changes discussed with Commissioners. Motion carried.

Commissioner Lyall moved and Commissioner Shenyer seconded a motion for the Port to pursue an interlocal agreement with the City of Grandview for the Port to share results of a Port consultant's broadband feasibility study, for a fee to be negotiated, not less than \$10,000. Motion carried.

- ii. <u>Property Signs</u> Executive Director Randy Tucker discussed locations for three new real estate signs recently purchased by the Port.
- iii. Wallace Way Business Park West Update
  - Motion to approve Pacific Power Development Backbone Contract and authorize Port President to sign.

Commissioner Shenyer moved and Commissioner Lyall seconded a motion to authorize the Port President to sign a backbone contract with Pacific Power for \$45,362 for electrical service to lots at Wallace Way Business Park West, and to authorize the funds transfer of \$45,362 from the 610-0220 Construction Fund to the 610-0210 General Fund.\* Motion carried.

\*Warrant #6137 for \$45,362 to Pacific Power was erroneously processed to come from the 610-0210 General Fund instead of the 610-0220 Construction Fund.

  Director Randy Tucker reported that the Quit Claim Deed
  has been signed by the Port, and that the Deed and check
  for fees will be sent to the Bureau of Reclamation on
  Friday, May 13<sup>th</sup>. The BOR will sign the deed and record it
  in Yakima County.
